The John and Olive Adams Foundation will award scholarships to qualifying students who plan to further their education at an accredited Idaho state college, university or technical college. The student must reside in Bingham, Bonneville, Fremont, Jefferson or Madison county.

Selection Criteria

- 1) The recipient must qualify under at least one of the following:
 - a. Top 20% of class;
 - b. 24 on ACT **or** 1110 SAT **or** equivalent score on Compass (80th percentile);
 - c. GPA of 3.5 or higher
- 2) The scholarship is limited to students who plan to study in the broad fields of either physical science or social science.
- 3) Preference will be given to students who have demonstrated financial need.
- 4) The recipient must attend an Idaho state sponsored university or technical college which is accredited by the Northwest Association of Schools and Colleges.

Application Procedure

Applicants must submit the following (please type or print):

- 1) A complete application signed by the applicant.
- 2) An official high school transcript which includes at least the first term of the Senior year.
- 3) Two letters of recommendation. One must be from a school official.

- 4) A resume of school and extracurricular activities.
- 5) A short statement of educational goals. Please include a paragraph indicating how this scholarship will further your education.
- 6) The name and address of the school ** to be attended.
- 7) The completed application and all supporting documents must be received by the Scholarship Committee by **April 17, 2017**
